1. Authority to sign and proof of identity practice guideline

The Department of Planning, Industry and Environment recently published the <u>Authority to sign</u> and proof of identity practice guideline. The guideline covers credit transactions that occur under the Biodiversity Offsets Scheme (BOS) including transfers, retirements, and assessment of reasonable biodiversity credit equivalence. The practice guideline outlines the legal authority required by a person to execute an application to transfer or retire BOS credits or for assessment of reasonable equivalence and the documentation required for proof of identity.

2. Test of significance – rebuilding after bushfire

The test of significance (section 7.3 of the *Biodiversity Conservation Act 2016*) is one of the triggers that decide whether the biodiversity offset scheme applies to a development. The test of significance is only relevant to threatened species, threatened ecological communities, or their habitats and should be prepared by a suitably qualified person (not necessarily an accredited assessor).

A test of significance is not required if the consent authority is satisfied that the footprint of a home being rebuilt after the 2019-20 bushfires plus any asset protection zone, does not contain

a threatened species, an ecological community or their habitats. Proponents and consent authorities can use the following resources to support this decision:

- <u>Threatened biodiversity profile search</u> for lists of threatened species and ecological communities by region, habitat and type of species.
- BioNet (<u>www.bionet.nsw.gov.au</u>) for Atlas of records of species and communities in the local area.
- Previous ecological assessment reports for the property.

The *Environmental Planning and Assessment Regulation 2000* requires the applicant to indicate whether development is likely to significantly affect threatened species. Best practice entails documenting any analysis or information relied upon to support a decision that a threatened species, threatened ecological communities or their habitats do not occur in the areas to be affected by the rebuilding proposal.

3. Biodiversity Offsets Scheme fees 2020-21

The Biodiversity Offset Scheme fees have been updated for the financial year 2020-21 to reflect the CPI. Please see Biodiversity Offsets Scheme fees.

The new fees will apply to all transactions from 1 of July 2020.

4. Update to Lot/DP display in BOAMS

A new structured Lot/ DP field has been added in BOAMS. This change will improve alignment with other applications and ensure consistency in the use of Lot/DP's. Please use the new fields creating new cases in BOAMS.

Note that the original Lot/DP field has been retained for data cleansing and to preserve existing data.

6. Display of Equivalent BAM credits on BOS public register (supply)



8. BCT update


Application status
